
Dear Msrs. McGuire, Bradburd and Andres:

Dear Judge Oles:

We the undersigned are the three members of the Donation Committee that was established pursuant to the Supplemental Stipulation and Agreement of Compromise and Settlement (the "Supplemental Settlement Agreement") in the above-captioned action. We are writing to provide the Court with a written report of donations, as called for the Supplemental Settlement Agreement.

Under the terms of the Supplemental Settlement Agreement in this action, adidas agreed to donate over a period of years \$1,000,000 in soccer-related merchandise (the "product donations") and \$160,000 in cash (the "cash donations") to charitable and/or non-profit organizations, soccer leagues, foundations and other organizations selected by the three members of the Donation Committee. Paragraph 9 of the Supplemental Settlement Agreement provides that, upon completion of the product and cash donations by adidas, the Donation Committee shall issue a written report itemizing each of the donations provided by adidas, and shall provide their report to class counsel, defense counsel and this Court.

We are pleased to report that, pursuant to the terms of the Supplemental Settlement Agreement, adidas has completed making all required product and cash donations to the entities and organizations selected by the Donation Committee. We have annexed as Exhibit A hereto a spreadsheet itemizing each of the donations made by adidas. This letter constitutes the written report of the Donation Committee.
